Upon his successful completion of the police academy, Detective Fraley worked as a patrol officer for approximately six years. During his time as a deputy, he worked both night and day shifts and also earned the title of Sergeant. Detective Fraley advanced his career at the Sheriff's Office even further in 2016 by advancing to the criminal investigations division as a detective, where he investigated cases involving thefts, burglaries, fraud, homicides, suicides, and many other criminal activities.
